

## Membership Contributions for the FCGH Alliance

- Full members shall contribute to the support of the FCGH Alliance in the following amounts based on membership category.
  - Membership is determined by two main categories; Organization or Individual.
    - Organizations have sub-categories based on how large the budget of the organization is and by the World Bank<sup>1</sup> country income level their country falls into.
    - Individuals have sub-categories based on their income level and by the World Bank Country Income level their country falls into.
  - Membership contributions are kept low, and with reduced fee and waiver possibilities, in order to ensure that fees are not an obstacle to membership, and particularly to enable lower-income individuals and organizations to join. Organizations and individuals in a position to provide higher contributions than the listed contribution levels are highly encouraged to do so.

- **Organisation size and annual revenue** (high, middle or low income country)
    1. Large organisation = > \$5,000,000 USD
    2. Medium organisation = \$2,000,000-\$4,999,999 USD
    3. Small Organisation = \$500,000-\$1,999,999 USD
    4. Very small organization = <\$500,000 USD
  - **Individuals**
    1. High Income Country
      - High Income = > 80,000 USD
      - Middle Income = 50,000 – 80,000 USD
      - Low Income = 30,000 – 50,000 USD
      - Very low Income/Students = < 30,000 USD
    2. Middle Income Country
      - High Income = > 50,000 USD
      - Middle Income = 30,000 – 50,000 USD
      - Low Income = 20,000 – 30,000 USD
      - Very low Income/Students = < 20,000 USD
    3. Low Income Country
      - High Income = > 30,000 USD
      - Middle Income = 20,000 – 30,000 USD
      - Low Income = 10,000 – 20,000 USD
      - Very low Income/Students = < 10,000 USD

**Sub category D**
